The Chairman Councillor James Williams welcomed two members of the Denbighshire Youth Club staff to the meeting. Arrangements are being made to view and copy the documents.

#### **MATTERS ARISING**

The Clerk referred to the following matters from the previous Minutes;

Minute no: 4. 127/16 – sub minute no: 9.97/16 & sub minute no: 4.69/16 – 10. 57/16 (page 3), in relation to the provision of a defibrillator in Dyserth. The Clerk advised that Councillor Peter Newell was still endeavouring to speak to the Clerk to Prestatyn Town Council.

Minute no: 4. 127/16 – sub minute no: minute no: 4.69/16 – 5(B). 71/16 (page 3), in relation to the alleged breach of planning at the Red Lion Pubic House, Waterfall Road. The Clerk advised in relation to further correspondence from Denbighshire Planning Department, which stated the following: 'the authority has received a valid retrospective planning application for the alterations made to the property. I have therefore closed the case down and no further action will be taken'

Minute no: 4. 127/16 – sub minute no: 10(A). 98/16 (3) (page 3), in relation to repairs to the vertical netting in the ball games area. The Clerk referred to the site visit by Councillors' together with Mr. Tony Chilton – and referred to a copy of the report that had been received by all Members of the Council.

Minute no: 4. 127/16 – sub minute no:14. 109/16 (page 3), in relation to the Members agreeing a yearly list of grass cutting schedule and frequency of visits. The Clerk advised that he had sent to Reg Davies & Son a copy of the agreed list – whereby the Company had confirmed receipt.

## COUNTY COUNCILLOR'S REPORT (CLLR DAVID G. WILLIAMS)

County Councillor David Williams provided the Members with the following update:

(i) Various footpaths – including Cross Keys Hill, Top of Waterfall area, near the Old school. The County Council will be writing to properties giving three weeks for the overhanging

- branches to be cut. Failure by the householder to comply, the County Council could complete the work and charge the household.
- (ii) The following concerns were being addressed: Waterfall steps to be cleaned and railings repaired including the provision of new railings in parts of the walkway. Hedges on Penrhaedr & Glasfryn pathway almost blocked. Ivy overgrowing wall outside the area of Pen Y Pandy towards the Surgery.
- (iii) The Clerk referred to concerns in relation to a footpath in the area of Tre Castell which had been reported to the County Council on a number of occasions. The Clerk to provide Councillor Williams with further information by e-mail.
- (iv) Councillor Mrs. Alison Williams referred to the railings in Weavers Lane that they County Council had agreed to repair and paint but had not been completed. Councillor Williams agreed to discuss this further with Denbighshire.
- (v) Councillor Williams advised that the traffic monitoring on Waterfall Hall, in particular, in relation to overweight vehicles is in progress.
- (vi) Parking concerns across from the New Inn being addressed by Highways.
- (vii) Councillor Williams had met with residents of Cae Ffyddion and members of Don't Destroy Dyserth Group to listen to their concerns.
- (viii) Anti-Social behaviour in Maes Esgob being address by both the County and Police.
- (ix) Tre Castell area water leakage. Councillor Williams has been in contact with Denbighshire County Council and the Water Board.
- (x) Councillor Williams had been contacted by residents outlining their concerns in relation to the proposed ski lift and café facilities.

# 6(A). 149/16 CORRESPONDENCE

# The following correspondence had been received, that was required to be either advised to, or dealt with by the Members;

- (1) PCSO Richard Williams had advised the Clerk in relation to the following reported criminal offences:
- (a) St. Asaph Road Criminal damage Youths have thrown a stone at a phone box in a resident's garden, the stone has shattered the glass. Enquiries are still on going.
- **(b)** Cwm Road Criminal damage Vehicle has had three of its tyres slashed. Suspect believed to be known to the victim and not a random attack.
- (c) Newmarket Road Unknown persons have been letting a pony out of its field at the rear of the properties on Newmarket Road.
- (d) Thomas Avenue Reports of a campervan parked outside of the school. Campervan had just been bought, the battery had died and they were awaiting recovery.
- (e) Bryn Y Felin Neighbourhood dispute Both parties have been advised
- (f) Maes Esgob Youths knocking on doors and jumping on cars This has apparently been reported to housing several times. Housing have stated to the caller that the youths are on their final warning. Housing will be contacted to attain who the youths are.
- (g) Maes Y Llys Incident between neighbours over an incident that happened a few years ago.
  - The Road Traffic Policing and VOSA will be conducting checks on Waterfall Road in the immediate future.
- (2) The Clerk referred to his e-mail dated the 14<sup>th</sup> July, 2016, which forwarded information from the Welsh Assembly Government in relation to the Draft Local Government (Wales) Bill.

- (3) Request from the National Library of Wales, in relation to the Library reproducing and archiving the Town Council's web site. **The Members agreed.**
- (4) Public Service Ombudsman for Wales Annual Report 2015 / 2016.

Whilst over 500 people attended during the day, there were only 45 people present at the evening event. The scarecrow competition was a success with 25 entries. (ii) Planning Application number: 42/2016/0643, at The Red Lion, Waterfall Road, Dyserth, for the removal of 2 no. dormer pediments and 1 no. chimney stack to front elevation (retrospective application).

Comment by Council: The Council are concerned that the removal of 2 no. dormer pediments, from a building sited in a conservation area, has changed the character and appearance of the building. It is noted that the application is being made retrospective. However, whilst the Community Council are displeased that the work has been carried out without consent – the Council do not object to the application – as long as the work that has been carried out is in accordance with planning policy, including conservation area regulations.

**Councillor Mrs. Alison Williams, wished the following to be Minuted:** Councillor Mrs. Alison Williams objected to the above planning application, at The Red Lion, Waterfall Road, Dyserth.
